- Tina informed the Senate of a floor upgrade in the dining hall due to the damaged floors and shared the different floor options. She also informed they are hoping to finish by September.
- Esha shared Feed the Block is cancelled this weekend due to COVID concerns, but Community Got Us will still be hosting their clean up on Sunday. She also informed San Jose Food Not Bombs will be serving food on Sunday and are still making care packages for the houseless on Friday and encouraged DASB members to participate.
- Nathan shared there was a meeting for housing yesterday and the college is considering both on campus and off campus housing but is heavily leaning towards off campus. He also shared the student housing survey only reach 1% of all students.

- Kimberly shared once they choose a location there will be a shared governance process in place and a resolution in regard to housing will be presented to Academic Senate and DASB. She also gave information about a Summer paid internship.
- Lianna reminded Senators they are supposed to be attending their shared governances and to let her know if they would like to change theirs. She also shared Yuetong will not be joining us today and there will be an ES workshop on March 9th and 11th from 11-1pm. Lastly, she shared there will be a College Council meeting tomorrow from 3-5 pm that President Lloyd has invited the Senate to attend.

- Max informed the Senate California Community Colleges hosted a live event webinar to raise awareness and celebrate black student achievements.

- Sunnie shared ASFC has seen an increase in zoom bombing solely surrounding Black History Month events and they approved the Green Monday resolution. She also announced there will be a return to info campus session on March 4th from 4-5 pm and a campus safety info session on March 11th from 4-5 pm.
- Nathan shared Curriculum Committee continued their course evaluations process.
- Luiza shared Classified Senate prioritized the housing meeting over the vote for the senate instructions, change in bylaws, and guiding paths.
- Kevin shared the Campus Senate Advisory Board had a presentation regarding the dining hall floors from Tina Lockwood.
- Iris shared Equity Action Council discussed the guided pathways proposal for the creation of villages and concerns brought up regarding the equity training faculty and professors went through.
- Katelyn shared information from her and Lianna's meeting with President Holmes. Katelyn shared Umoja received a presidential allocation of \$10,000, \$200 million was allocated to housing but does not fully cover the costs associated with it, explained why President Holmes and the board are not in favor of on campus housing, and President Holmes is looking to hire a De Anza Development Director to raise funds.
